TERMS AND CONDITIONS:

1. The Bids shall be submitted in two parts in separate sealed inner envelopes and shall be put together in a larger outer envelope. The outer envelope shall be addressed to Superintending Engineer, Procurement & Contracts Wing, PHPA-II, Bjimthangkha, Wangdue, Bhutan duly marked **"Confidential"** with **Lot Number, Type & Registration No. of Vehicle**. The Bidder shall provide a warning not to open before the specified time and date defined in the notice above.

The inner envelope shall be duly signed & indicate the name and address of the bidder with clear envelope number and the content of the envelopes detailed as under.

1.	Part-I	Earnest Money (EMD)
2.	Part-II	Price bid along with signed copy of terms & Conditions (Original)

2. The bidders can quote for one or all the Lots. However, the bids have to be submitted separately for individual lot.
3. Earnest Money (EMD) of Nu. 10,000.00 shall be furnished for each lot in the form of Demand Draft drawn in favour of PHPA-II payable at Bank of Bhutan, Wangdue. No interest shall be paid on the EMD.
4. EMD of successful bidder/highest bidder shall be adjusted against the quoted price. The EMD of unsuccessful bidders shall be returned not later than 30 (Thirty) days after the expiry of bid validity period.
5. EMD is liable to be forfeited if:
 - i. Bid is withdrawn during the period of its validity.
 - ii. Correction of bid price is not accepted by the bidder.
 - iii. Successful bidders fail to pay the full quoted price for the vehicle within the prescribed time.
6. The successful bidder shall make payment of 25% of the quoted price within 5 (Five) working days and balance 75% within 10 (Ten) working days from the date of acceptance of bid in the form of Demand Draft drawn in favor of PHPA-II payable at Bank of Bhutan, Wangdue.
7. The successful bidder shall take the delivery of vehicle at his own cost within 10 (Ten) working days from the date of acceptance of bid against full payment. The change of ownership of vehicle must be done within 15 days after taking delivery of vehicle and the applicable Taxes/Charges shall be borne by the successful bidder.
8. The decision of the PHPA-II to accept or reject the bid without assigning any reason shall be final and binding.



9. It will be assumed that the bidders have inspected the vehicles to be auctioned and that the bid offered is at his own liberty & judgment. No complain shall be entertained at later date.
10. The bid shall be valid for 60 (Sixty) days from the date of opening of the bids.
